- **Payment:** Prepayment is required from individuals. Businesses or government agencies may use purchase orders. Deposit may be required.
- **Shipping and handling charges: \$3.00. Actual postage costs will be added to large orders.**

Copyright and Use Policies:

1. All photographs, audio-visual materials, and digital images are the property of Sherratt Library, Southern Utah University. Reproduction or redistribution of these is forbidden without the express written consent of Special Collections, Sherratt Library, Southern Utah University. Adding pointers to the Library's World Wide Web pages IS permitted, even encouraged.
2. Photographic materials do not circulate and must be used in the Christopher-Mann Reading Room. No prints or negatives will be loaned for copying, but copies can be purchased from Special Collections.
3. If a negative for the requested item is not on file, the Library can make a print from a scan or have a 4 x 5 inch copy negative made to fill the order. The patron assumes the cost for either the scan (\$5) or the negative (\$10). All such copy negatives will be retained by the library. Copy negatives are not sold to patrons.
4. No photocopying of original photographs is allowed without express permission from the Special Collections librarian.
5. Any one time, non-exclusive use of photographs for publication, exhibition, or other purposes requires written permission from this department. Use fees are charged for use of photograph, audio-visual or any other graphic materials or images from Special Collections, Sherratt Library. See Photograph Use and Reproduction Fees.
6. Materials used for exhibition or publication must be credited to Special Collections, Sherratt Library, Southern Utah University.
7. The publishing party will supply Sherratt Library, Southern Utah University, with one copy of the book, periodical, video, or any other work in which a photograph is published.
8. The library does not claim to control the copyright for all materials in its various collections. The publishing party assumes all responsibility for clearing reproduction rights and for any infringement of United States copyright law. The library has no readily available information concerning the existence and/or whereabouts of copyright holders.
9. The library reserves the right to refuse permission for use or reproduction of materials when such restrictions have been specified by donor.
